

# FREQUENTLY ASKED QUESTIONS

### 1. What is on the March 10, 2020 ballot?

On March 10, 2020, voters in the Plymouth-Canton Community Schools' communities will be asked to consider a bond proposal for facility and site improvements addressing equity of facilities, enhancing safety and security throughout the school district, furniture and playground upgrades, school bus purchases, and addressing imminent infrastructure and technology needs at most facilities. The bond proposal requests voter approval for the issuance of \$275 million of bonds by the District to finance these facility and site improvements. If approved by the voters the plan would be to issue the bonds in 3 separate series of bonds over a 6 year period.

<u>Estimated ZERO INCREASE to the current annual debt millage rate</u>: If the bond proposal is approved by the voters it is estimated that the annual debt millage required to repay the District's outstanding and the proposed bonds will remain at or below the current debt millage rate of 4.02 mills.


## 2. How was this plan developed?

- P-CCS Administration engaged TMP Architecture and McCarthy & Smith to facilitate
  District-wide visioning sessions. The purpose was to develop potential programming
  and teaching needs throughout the District. The theme of the sessions was 'Equity' at
  all grade levels.
- As a part of the visioning sessions, the District enlisted a group of Board of Education members, administration, staff, parents, students, and community stakeholders to discuss the imminent infrastructure and programmatic needs within P-CCS.
- The visioning sessions were conducted February 2019 thru May 2019. Members from each school level met independently in order to discuss the needs at their facility.
- Following the visioning sessions, a public workshop session with the Board of Education was held to present the findings from the study and provide input and further direction.
- In November, 2019, the Board voted to place the \$275 million bond initiative on the ballot. The proposal would result in an estimated ZERO INCREASE to the current annual debt millage rate of 4.02 mills.

## 3. What are the features of the 2020 Bond proposal?

2020 Bond touches every building in the District with a focus on creating equity across all schools, addressing imminent building and site infrastructure issues, enhancing learning spaces through both remodeling and building, and upgrading technology throughout the District. ### 6. What are the features of 2020 Bond across all buildings?

2020 Bond touches every building in the District with a focus on creating equity across all schools. In doing so, the upcoming Bond will build upon the Program Enhancements and Learning Environments Improvements completed in the 2013 Bond. Buildings at all grade levels that did not receive upgrades during that time, including safe and secure entries, will be enhanced.

# 8. In 2013, Plymouth-Canton Community Schools voters supported a bond proposal. What did this bond result in for the district?

The 2013 Bond addressed security and instructional technology in all schools with a focus on student learning, technology, health, safety, and security at our facilities and sites. The four main features of the 2013 Bond program included technology enhancements, upgrades to all district facilities and sites to address aging infrastructure, replacement of Central Middle School with the construction of Liberty Middle School, and additions to the existing middle schools, as well as the purchase of buses.

## 9. How will the 2020 Bond proposal impact P-CCS students and the community?

It is the District's goal to continue to provide facilities that support 21st century teaching and to advance learning conditions and methods of instruction to better prepare students for meeting the expectations and demands of employers and colleges / universities in the future. Additionally, the Board of Education believes that the upgrades that have been identified in the assessment process, and given high priority by the professional team, support proper stewardship of the community's investment in our schools. In addition, P-CCS' school facilities and sites are regularly used by community members for recreational / athletic opportunities and events, meetings, performances, and senior citizen activities and the upgrades proposed for these community-use spaces will continue to serve our broader community in a variety of ways.

#### 10. What is 'collaborative learning space' and why is it important in schools today?

Collaborative learning spaces within a school allow students to learn effectively in groups, encouraging each other to ask questions, explain and justify their opinions, articulate their reasoning, and elaborate and reflect upon their knowledge. The teacher then acts as a facilitator, helping students with their research and guiding them through the learning process.

Research has found this to be beneficial in helping students learn effectively and efficiently versus more traditional independent learning. Some positive results from collaborative learning activities have been documented in research and include:

- Students are able to learn more material by engaging with one another and making sure everyone understands.
- Students retain more information from thoughtful discussion.
- Students have a more positive attitude about learning and about each other by working together.

To create collaborative learning spaces, we need to provide the resources for information processing, collaboration, assistance, and management of the learning activities. These include technology, flexible furniture that allows for different configurations, appropriate lighting, acoustical control and finishes.

## 11. Why is it important to attract and retain students in the District?


Public schools in Michigan receive operating funds on a per-pupil basis. Attracting and retaining students is critical for P-CCS. The quality of our programs and facilities plays a role in both of these areas. If approved by the voters, the bond program would upgrade facilities to support updated teaching methods, improve operational efficiencies in our facilities, provide progressive learning environments, and protect and maintain the community's past investment in our school buildings. Parents have choices regarding where their children will receive an education. It is the intent of the Board of Education and the District to maintain its reputation for providing quality programs and facilities in order to attract and retain students.

## 12. How are neighboring districts addressing the aging condition of their schools?

Neighboring districts have experienced the same issue of continually aging buildings. Bond programs have been approved and implemented all around us, including Farmington with \$131.5 million in 2015, Northville Public Schools with \$104.85 million in 2017, Wayne-Westland Community Schools with \$158 million in 2018, Huron Valley Schools with \$182 million in November 2019, Ann Arbor Public Schools with \$1 billion, and Novi Community Schools with \$185 million in November 2019. In today's competitive environment, districts seek every advantage.

## 14. How much would the bond proposal cost the average taxpayer?

If voters approve the bond proposal, it is estimated that the annual debt millage required to repay the District's outstanding and proposed bonds will remain at or below the current debt millage rate of 4.02 mills. Thus, it is estimated that there will be no increase over the current annual debt millage rate. Funds would be generated for this bond proposal through an extension of the current debt rate.



## 15. Can I deduct these property taxes on my income tax return?

Property taxes may be deductible as itemized deductions on your federal income tax return if you itemize. You may also be eligible for the Michigan Homestead Property Tax Credit on your Michigan Income Tax Return. Please consult with your tax preparer.

## 16. What exactly is the Michigan Homestead Property Tax Credit?

The Michigan Homestead Property Tax Credit is a method through which some taxpayers can receive a tax credit for an amount of their property tax that exceeds a certain percentage of their household income. This program establishes categories under which homeowners or renters are eligible for a homestead property tax credit. Please consult with your tax preparer to determine if you are eligible for this important and valuable tax credit.

## 17. Economically, is this a good time for a bond proposal?

Options are limited to Michigan school districts when considering large capital improvement projects. Funding for K-12 public education over the past decade and increased operational expenditures make it cost prohibitive to consider paying for major capital improvements out of a school district's general operating funds. Therefore, taxpayer-supported bond issues continue to be the most fiscally responsible option to invest in school district capital improvements.

The Board of Education and school administration have conducted a thorough review of District needs. Critical upgrades have to be addressed in order to maintain an appropriate learning environment for our students and staff and to avoid potentially increased costs in the future. This bond program is fiscally responsible for a couple key reasons highlighted below:

- Estimated <u>ZERO INCREASE</u> to the current annual debt millage rate: Due to the
  unique structure of P-CCS' outstanding bond issues, bond millage rates are projected
  to decline without a new bond issue. This gives the District an opportunity to
  accomplish a number of projects without increasing the current millage rate of 4.02
  mills.
- 2. **Historically Low Borrowing Rates**: Municipal bond interest rates are near historical lows just like your personal mortgage rates. As a result, the cost to borrow for the District, and ultimately the loan payments paid by taxpayers, are more desirable than they have been in the past or will be if rates rise again.

#### 18. What if the bond proposal millage doesn't pass?

P-CCS owns more than \$330 million in properties. During the past decade, the rising cost of operating the school system has put tremendous pressure on the District's general operating fund. Failure to approve the bond proposal will mean the District would not be able to accomplish much-needed improvements, and that any emergency improvements to address potential safety issues at the District's facilities will have to be paid for with reprioritized general operating funds that would otherwise go to support educational programs for students. Additionally, educational facilities and program enhancements such as the robotics space, collaboration space, and transforming our classrooms to meet modern learning methods, would not be possible at this time, potentially impacting opportunities and programs for our students.

# 19. Can money from the bond program be used to pay for salaries and benefits for personnel, such as teachers?

No, that is against State law. Bond dollars cannot be used for operational expenses such as employee salaries, upgrades, facility maintenance, or energy costs. Bond program funds must be accounted for separately from general operating funds. Bond funds are also subject to audit.

#### 20. Please explain what bond program money can cover and what it cannot.

Bond proceeds cannot be used for the following items:

- Salaries and wages
- General operating expenses and maintenance
- Classroom supplies and textbooks

Bond proceeds **can** be used for the following items:

- Construction and remodeling of facilities
- Purchase of instructional technology equipment
- Equipment and furniture
- Site improvements
- Bus purchases

## 21. What are the key dates leading up to the March 10 election?

Voter registration and absentee voting procedures have changed since the last election.

# 22. If I cannot make it to the polls on March 10, 2020 what are my options for absentee voting?

Due to a recent change in the law, all eligible and registered voters in Michigan may now request an absent voter ballot without providing a reason. The deadline to request an absentee ballot via First Class Mail is Friday, March 6, at 5 p.m., and voters may also obtain an absent voter ballot in person in the clerk's office up to 4pm on Monday, March 9. The deadline to return a completed absentee ballot is Tuesday, March 10, at 8 p.m.

- In your school building offices
- At your City Clerk's office

Note: Once election ballots are available in the clerk's office, you can walk into your clerk's office, receive an absentee application, fill it out, and immediately be given your ballot to cast your vote.

## 23. Where do I register to vote?

To vote in the March 10, 2020 election, you must be a U.S. citizen, at least 18 years of age by Election Day, a resident of Michigan and of Plymouth-Canton Community School District. Please visit your local township or city clerk to register to vote or visit any Secretary of State office. Printable voter registration forms are available on the State website, www.michigan.gov/vote.

Due to a recent change in the law, eligible individuals may now register to vote in the clerk's office up to and including the Election Day.

## PLYMOUTH-CANTON COMMUNITY SCHOOLS COUNTIES OF WAYNE AND WASHTENAW STATE OF MICHIGAN

#### SCHOOL IMPROVEMENT BOND PROPOSAL

Shall the Plymouth-Canton Community Schools, Counties of Wayne and Washtenaw, State of Michigan, borrow the sum of not to exceed Two Hundred Seventy-Five Million Dollars (\$275,000,000) and issue its general obligation unlimited tax bonds, in one or more series, for the purpose of paying for the cost of the following projects:

- Remodeling, equipping, re-equipping, furnishing and re-furnishing school buildings, performing arts center, activity and athletics fields, playgrounds and other facilities for safety and security, energy conservation and other purposes;
- Erecting, completing, equipping and furnishing a new stadium, activity and athletic facilities
  and maintenance/storage facility and secure entryway, classroom, gymnasium, and
  natatorium additions to existing school buildings, athletic fields and other facilities;
- Acquiring and installing instructional technology infrastructure and equipment in school buildings and other facilities and the purchase of school buses; and
- Preparing, developing and improving sites at school buildings, playgrounds, activity and athletic fields and other facilities for traffic control, safety and security and other purposes?

The annual debt millage required to retire all bonds of the School District currently outstanding and proposed pursuant to this Proposal is expected to remain at or below the annual debt millage of 4.02 mills levied in 2019. The maximum number of years any series of bonds may be outstanding, exclusive of refunding, is not more than twenty (20) years; the estimated millage that will be levied to pay the proposed bonds in the first year is 0.98 mills (which is equal to \$0.98 per \$1,000 of taxable value); and the estimated simple average annual millage that will be required to retire each series of bonds is 1.65 mills annually (\$1.65 per \$1,000 of taxable value).

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for teacher, administrator or employee salaries, repair or maintenance costs or other operating expenses.)
