Action Item #24-11-27: It was moved by Member Sidhu and seconded by Member Christenson to Approve
a Resolution to purchase a 2023 GMC Savana 2500 Standard Cargo Van to replace a stolen maintenance
truck. The recommended vendor is Todd Wenzel Buick GMC in Westland, MI, at a cost of \$34,237. Insurance
reimbursement of \$14,000 and the remaining \$20,237 will be paid from the Operations Department vehicle

• Consider Approval of a Resolution for a Course Name Change Request. The P-CEP instructional team has proposed changing the course name of Honors Photography to AP 2-D Art and Design Portfolio. This course already follows the AP 2-D Art and Design curriculum. Changing the title will allow students who complete this course to have the Advanced Placement (AP) designation on their high school transcript. If this request is approved, the course name will change to AP 2-D Art and Design Portfolio beginning with the 2024-2025 school year and will be offered with two options – one focused on drawing and the other on digital media (photography). There will be no cost for implementing this requested course name change. (First Reading)
