#### **Superintendent's Report**

Superintendent Merritt provided an update on this morning's Teacher Welcome-Back Event, held at the Gloria Logan Auditorium. Educators from across the district took part in professional development and were inspired by guest speaker, Hamish Brewer, whose motivational message urged staff to continue making a lasting difference in students' lives. She also recognized the P-CEP Saxophone Quartet for their outstanding performance and thanked President Christenson for her uplifting opening remarks.

Superintendent Merritt shared that the P-CCS Back-to-School Bash, previously postponed due to Joy Road construction, has been rescheduled for Thursday, September 26, from 4:30 to 7 p.m. at the P-CEP bus loop.

She encouraged the community to come out and enjoy an afternoon of games, food, and fun and to learn more about the wide range of programs the district offers to students. The event will also feature tours of the high school campus and opportunities to meet district leaders.

Additionally, she expressed gratitude to the Native American Heritage Fund for its generous support as the district prepares to launch the next phase for the new Canton High School mascot. P-CCS applied for a grant & has been awarded \$145,894 to support the rebranding costs of the new Canton High School Cobra Mascot.
